Mortgages - MORTGAGE TRANSFER

STATE OF ALABAMA

KNOW ALL MEN BY THESE PRESENTS, That for value received, I, Roy Hoffman, as Administrator of the Estate of Walter Hoffman, deceased, do hereby transfer, assign, set over and convey unto John Milton Hightower those two certain mortgages executed by J.J. Hightower and M.G. Hightower and their wives to Walter Hoffman, now deceased, one of which mortgages bears date December 10th, 1927, and is recorded in the Probate Office of Talladega County, Alabama, in Volume 187, page 327, and the other of which mortgages bears date February 4th, 1928, and is recorded in Mortgage Book 152, page 99, Shelby County, together with the notes and indebtedness secured by said mortgages and all interest under said mortgages in and to the real property described and conveyed thereby.

By instrument bearing date August 11th, 1933, the indebtedness secured by both of said mortgages was extended and consolidated in to one Series of twenty-five (25) notes for Four Thousand (\$4,000.00) Dollars each, payable annually on November 1st of each year commencing November 1st, 1934 with interest upon said notes only after maturity. The first ten (10) of said notes have been paid and the remaining fifteen (15) of said notes are hereby transferred and conveyed. It is understood that this assignment is made without the right to recourse ^{upon} the undersigned.
