Logan about 23 years ago and that the said O. L. Logan and his wife, A. B. Logan have resided on, owned and been in actual possession of all of the property herein described under claim of right for a period of more than twenty years and that during all of said time the possession of the said O. L. Logan and his wife has been continuous, peaceable, exclusive, actual, open and under claim of ownership for said period of more than twentyyears and that their title has not been disputed by anyone during said time.
