J.H. Hamilton and wife G.C.Hamilton for and in consideration of the sum of One Dollars (\$1.00) to us in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers upon, over and across the following described lands situated in Shelby County, Alabama:

Beg. at North east corner of Block 6 according to Saffords survey of Town of Shelby Alabama recorded in the Probate Office of Columbiana, then west along the south boundary line of Parker Avenue 420 feet to a point of beginning then South parallel to 3rd street 342.7 feet to north boundary line of Eighth Avenue then west along North boundary line of 8 avenue 379 feet to last boundary line of First street then north along East boundary line of First street 374.4/feet to South boundary line of Parker Avenue then east along South boundary line of Parker Avenue 315feet to point of beginning of Shelby County, Ala.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns forever.
