Burton, and wife Mrs. Alma Burton, for and in consideration of the sum of One Dollars (\$1.00) to us in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corpor: tions and persons to attach wires to said poles and towers upon, over and across the following described lands situated in Shelby County, Alabama:

Begin at a point in the north line of Sec 30 Tp 19 Range 1 E which point is nine hundred ninety feet (990) West of the northeast corner of Sec 30 run thence west 330 feet to the Northwest corner of NEL of NEL Sec 30 thence south along the west line of said 40 to the Florida Short Route highway thence east along said right of way right of way/330 ft thence north to the point of beginning in the NEL of NEL Sec. 30 Tp. 19 R.l E

Together with the rights and privileges necessary or convenient for the full enjoyment or use thereof including the right of ingress and egress to and from said lines; an also the right to cut and keep clear all trees, and to keep clear other obstructions that may injure or endanger said lines.
