## LINE PERMIT

Rebekah S. Smith the wife of R.W. Smith for and in consideration of the sum of One Dollars (\$1.00) to in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and applicances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers upon, over and across the following described lands situated in Shelby County, Alabama:

3 acres more or less in Beginning on the South line of the Right of way of the Montevallo and Columbiana Highway at the point of intersection thereof with the line separating Sec 4 and 5 thence south along sec line 420 feet thence East and parallel with said highway 315 feet thence north 420 feet to the South line of the right of way of said highway thence west along said South line 315 feet to point of beginning of SVA of NWA Sec 4 Tp 24 R 13 East

Together with all the rights and priv leges necessary or convenient for the full enjoyment or use thereof, including the right of ingress am egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns forever.
