Miller do grant, bargain, sell and convey unto the said Rufus McGinnis the following described real estate, to-wit:

One lot, commencing at an iron stake one hundred sixty (160) feet from the section line, or Wilson field fence, being on main street or Elyton Road in the Town of Montevallo, Alabama, and running along said Street or Road east One hundred Sixty (160) feet to the said section line or Wilson field fence, Thence south two hundred thirty (230) feet, being just below a large cedar tree, Thence Northwesterly One hundred seventy five (175) feet to the point of beginning. Being a triangular Lot, bound east by Section line or Wilson field, on Southwest by the Nero Brazier Lot, and on the North by Main Street or Elyton Road.
