Begin at SW corner of SW¹/₄ of NW¹/₄ of Section 33, Tp. 21: Range 3 West; Run north 87¹/₂

degrees East 580 ft. to a point on the east side of the Southern Railway Right of Way

to a settlement Road; thence 87¹/₂ degrees east 557 feet

thence north along east side of said Railway R/W 460 ft./to a point on Montevallo
Elyton road; thence north 2¹/₂ degrees east along west side of road 285 feet to a point;

thence South 85 degrees West 1276 feet to west line of said forty acres, thence South

2¹/₂ degrees east 804 feet to the point of beginning. Containing 15 acres more or less

and being in the SW¹/₄ of NW¹/₄ of Section 33, Tp. 21, Range 3 West.
