the said B. L. Hester and wife, Dessie Hester do grant, bargain, sell and convey unto the said J. E. Cater

the following described real estate, situated in Shelby County, Alabama, to-wit:

Beginning at a point 881 feet North of the Southeast corner of the NE+ of the NE+ of Section 4, Township 22, Range 2 West, and run North 870 feet; thence West to the West line of the right of way of Birmingham-Montgomery Highway for a point of beginning; thence continue West to the East line of the Columbiana and Montevallo Public Road; thence South-west along the East line of said last mentioned public road to a point where the East line of the NW+ of Section 4, Township 22, Range 2 West crosses said road; thence South along the East line of the NW+ of NW+ of Section 4, Township 22, Range 2 West to the Northwest corner of the land formerly owned by Sallie Bird; thence East along the North line of said Sallie Bird Land to the West right of way line of the Birmingham-Montgomery highway; thence Northwest along said right of way to the point of beginning and containing 40 acres, more or less, except ½ acre reserved as Cemetery lot.
