Nabors, in hand paid by J.E. Wright and wife Katie Sumrall Wright, the receipt whereof is acknowledged we the said W.H. Nabors and wife Hazel B. Nabors, do grant, bargain, sell and convey unto the said J.E. Wright and wife Katie Sumrall Wright, the following described real estate, to-wit:

The Southeast Quarter of Southwest Quarter (SE of SWL), the Northwest quarter of the Southwest quarter (NWL of SWL) and the Southwest quarter of the Northwest quarter (SWL of NWL), of Section 26, Tp. 19, Range One (1) west, containing One Hundred Twenty (120) acres, more or less. All minerals and mining rights are excepted herefrom. Also all that portion of the Northwest quarter of Northwest (NWL of NWL) of Section 26, Tp. 19, Range 1 West, lying south and east of a line described as follows: Begin on the East line of said quarter quarter section at a point 250.5 feet South of the Northeast corner thereof; thence run South 36 deg. 45: west 206.3feet; thence run South 48 deg.
