C. Foster Lot, and now known and owned by Cora Lee Nora Tolbert, and run thence in a Northerly direction along the West line of the R. C. Foster Lot, now known as the Tolbert Lot to the Southeast corner of the I.G. Gwin Lot, run thence in a Westerly direction along the South line of the Gwin Lot to the Eastern right of way line of the State Highway; run thence in a Westerly direction along the South Right of way line of said State Highway to the Northwest corner of the Taylor Gin House Lot; run thence in an Easterly direction along the North boundary line of the Taylor Gin House Lot to the Northeast corner thereof; run thence in a Southerly direction along the Eastern boundary line of said Taylor Gin Lot to the point of beginning.
