Part of SE of SE Sec. 12, Tp. 21, R 3 W beginning at SE corner of said 40 and running west along forty acres 800 feet to an iron stake; thence north 130° east 150 feet to an iron stake on south side of L & N R. R.: thence west along said right of way 535 feet to east line of Sec. 12; thence along said line to the point of beginning.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns for ever.
