Transmission Line Permit

Henry and wife, Essie Henry for and in consideration of the sum of One Dollars (\$1.00) to us in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers upon, over and across the fallowing described lands situated in Shelby County, Alabama:

Lot in SE4 of SE4 Sec. 12, Tp. 21 R 3 W. described as follows: Begin 38 feet East of SW corner and run East 370 feet; thence NW 365 feet to Elliotsville road; thence SW to point of beginning

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endnager said lines.

TO HAVE AND TO HOLD the same to the said Company, its succesors and assigns forever.
