KNOW ALL MEN BY THESE PRESENTS, That I, Fannie Frances Farrell, widow of S. M. Farrell, deceased, now residing at 629 North Eightieth Street, in the city of Birmingham, Jefferson County, Alabama, being of sound mind and disposing memory, do hereby make and declare this to be my last will and testament, revoking any and all wills heretofore made by me at any time.

1. I direct that all of my just debts and funeral expenses be paid as soon after my decease as conveniently can be done.

2. I give and bequeath to my stepson, James Samuel Farrell, Fairmont, Birmingham, Alabama, the sum of One Dollar (\$1.00).

3. I give and bequeath to each of my children, namely, Mrs. Audrey Malvin Sloan, Route 2, Trussville, Alabama, Arnold A. Farrell, Mt. Olive, Alabama, E. E. Farrell, 2408 Thirty-second Avenue North, Birmingham, Alabama, Mrs. C. J. Steele, Route 2, Trussville, Alabama, Mrs. R. B. McKee, Fort Worth, Texas, and Mrs. E. B. McClasky, Pensacola, Florida, the sum of One Dollar (\$1.00) each.

4. I give, devise and bequeath to my daughter, Stella Farrell, the following described real property situated in Shelby County, Alabama, to have and to hold the same to her absolutely and forever: SW $\frac{1}{2}$  of SW $\frac{1}{4}$ , Section 18, Township 20, Range 1 West; SE $\frac{1}{4}$  of SE $\frac{1}{4}$ , Section 13, Township 20, Range 2 West; NE $\frac{1}{4}$  of NE $\frac{1}{4}$ , Section 24, Township 20, Range 2 West; and the NW $\frac{1}{2}$  of NE $\frac{1}{4}$ , Surface rights only, Section 24, Township 20, Range 2 West. I further give, devise and bequeath to my said daughter, Stella Farrell, all the right, title, claim or interest I have or may have at the time of my decease in and to the following described real property situated in Shelby County, Alabama: Mineral rights to the E $\frac{1}{2}$  of SE $\frac{1}{4}$  of NE $\frac{1}{4}$ , Section 17, Township 20, Range 1 West; and SE $\frac{1}{4}$  of NW $\frac{1}{4}$ , and S $\frac{1}{2}$  of NE $\frac{1}{4}$  of NW $\frac{1}{4}$ , Section 25, Township 21, Range 2 West. All the rest of my real and personal estate of which I shall die seized and possessed, or to which I shall be entitled at my decease, I give, devise and bequeath to my said daughter, Stella Farrell.

5. I nominate and appoint my said daughter, Stella Farrell, to be the sole Executrix of my Estate and direct that she be exempted from giving an official bond, and so far as I may I direct that she be relieved of making any report or reports of her acts as such Executrix to any court.
