2½ acres more or less in the SW4 of NW4 and 60 acres and being in the SW4 of NW4 and the SE4 of NW4 and NE4 of SW4 all in Sec. 18, Tp 22 R 1 E.

Together with all the rights and privileges necessary or commendent for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.
