The undersigned Amos McCreary, of Ensley, Jefferson County Alabama, being desirous of directing the disposition of whatever property I may own at the time of my death do hereby make, publish and declare this my last will and testament: That is the manner and form following:

FIRST: I direct that all my just debts including my funeral expenses be paid so soon after my decease as may be reasonably convenient.

SECOND: I hereby give devise and bequeath all my property of every kind and description, including all real estate and personal property and all mixed real estate and personal property to my wife Amelia Dobbs McCreary to have and to hold unto her use and benefit forever.

THIRD: I hereby nominate and appoint my wife Amelia Dobbs McCreary as the Executor of this will, and direct that she be not required to give bond or security for her acts as such executor but that she serve without bond. I further direct that she be not required to file any inventory with any court or make any report or settlement of her acts as such executor with any court.
