KNOW ALL MEN BY THESE PRESENTS, That in consideration of TWO HUNDRED SEVENTY-FIVE & NO/100 DOLLARS to the undersigned grantors E.J. Poole and wife, Myrtie Poole, in hand paid by Troy L. Henderson, Sr., and wife, Eva Edna Henderson, the receipt whereof is acknowledged we the said E.J. Poole and wife, Myrtie Poole, do grant, bargain, sell and convey unto the said Troy L. Henderson, Sr., and wife, Eva Edna Henderson, the following described real estate, to-wit:

That certain tract of land situated in the South Half of the Northwest Quarter of the Northwest Quarter of Section 14, Township 21, Range 3 West, described as follows, to-wit: Commencing at the Northwest corner of said Section 14, and run thence South along the West line thereof a distance of 660 feet; run thence East and parallel with the North line of said Section 14 a distance of 1100 feet, more or less, to a point on the Western margin of the Montevallo public road, said last named point being the Northeast corner of that tract of land conveyed by J.J. Smylie to E.J. Poole and wife, Myrtie Poole, by deed dated October 26, 1945, and conveying 25.2 acres, and run thence in a Southerly direction along the West margin of the right of way of the said Montevallo public road a distance of 400 feet for a point of beginning of the lot or tract hereinafter described and conveyed: From said last named point run thence in a Southerly direction along the Western margin of the Montevallo public road a distance of 100 feet; run thence West and parallel with the North line of said Section 14 a distance of 600 feet; run thence in a Northerly direction and parallel with the West right of way line of the Montevallo Public road a distance of 100 feet; run thence East and parallel with the North line of said Section 14, a distance of 600 feet to the point of beginning; and containing 1.3 acres, more or less, and designated as TRACT NUMBER FIVE by the grantors herein and situated in Shelby County, Alabama.
