Goodwin, the receipt whereo is hereby acknowledged, the said Queen-Alton Investment Company does grant, bargain, sell and convey unto the said C. C. Goodwin the following described real estate, to-wit:

The W. 1 of the SW 4 of Section 33, Township 17, Range 2 East.

All that part of the SE  $\frac{1}{4}$  of the SW  $\frac{1}{4}$  lying South and West of Kelley's Creek.
