Polcombe, and all persons claiming or to claim said premises, or any part thereof, through or under said respondent, are hereby adjudged and decreed to be invalid and groundless: and that the complainant be, and he is hereby, declared and adjudged to be the true and lawful owner of the lands described in the bill of Complaint, and hereinafter described, and every part or parcel thereof, and that his title thereto is adjudged to be quieted against all claims, demands, or pretentions of the respondent, who is hereby perpetually estopped from settingcup any claims thereto or any part thereof. Said premises are abounded and described as follows: to-wit:

All that part of the southeast quarter of the northeast quarter and of the northeast quarter of the southeast quarter and of the south half of the northwest quarter of the southeast quarter of Section 8, Township 24, North, Range 13, East, described as follows: beginning at the southeast corner of the northeast quarter of the southeast quarter of said section 8 and run thence north along the east section line thereof to the pointst
