RIGHT-OF-WAY DEED FOR PUBLIC ROAD

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, T. F. PRESTRICGE AND WIFE ALICE PRESTRICGE of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be (see below) feet in width on each side of the center line of said road, as it is now located and staked out by Shelby County or as much of our lands as is required to make a 80 foot right-of-way across our lands, said right-of-way herein conveyddbeing more particularly described as follows, to-wit: and as shown by the right-of-way map of SACP 414 as recorded in the office of the Judge of Probate of Shelby County:

Beginning at station 384 / 15.5 of said Project, the south property line; thence 225.7 ft. northwesterly along a 2864.93 ft. radius curve, concave northeasterly; thence 509.6 ft. N14⁰53'W; thence 407.7 ft. northwesterly along a 1910.08 ft. radius curve, concave easterly, to station 395 / 58.5, the point of ending at the north property line.

Said strip of land being 40 ft. wide on the northeast side of the centerline of said Project from station 384 / 15.5 to station 393 / 000, 40 ft. wide on each side of said centerline from station 393 / 90 to station 395 / 58.5, excluding area lying southwest of the centerline of the present road.

Said strip of land lying in the S_2^1 of NW_4^1 of Section 23, Tn. 21 S, Rn. 3 W and containing 1.0 acres, more or less, including area occupied by the present road.

To Have and To Hold by Shelby County, or its Assigns, and for and in consideration of the benefit to our property by reason of the construction or improvement of said road, we hereby release the County aforesaid, and all of its employees and officers, and the State of Alabama and all of its employees and officers from all consequential demages, present or prospective, to our property, arising out of the construction, improvement, maintenance or repair of said road, and that said road is a benefit

to our property by reason of the construction or improvement of said road, we hereby release the County aforesaid, and all of its employees and officers, and the State of Alabama and all of its employees and officers from all consequential damages, present or prospective, to our property, arising out of the construction, improvement, maintenance or repair of said road, and that said road is a benefit to our property is hereby admitted and acknowledged. All agreements covering the moving, relocating and/or changing of the buildings and/or structures located wholly or partially on the above described right-of-way shall be in writing and approved by the State Highway Department before same shall be valid and binding on the said State Highway Department. The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
