know all men by these presents, that we, the undersigned, Mrs. Gertrude Kirkley of the County and State aforessia, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction of improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successor or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County. Alabama, for a public road; which right-of-way shall be 30 feet in width on right side of the center line of said road, as it is now located and staked out by the State Highway Department or as much of our lands as is required to make a 30 foot right-of-way across our lands, said right-of-way herein conveyed being more particularly described as follows, to-wit: and as hown by the right-of-way map S.A.C.P. 414, as recorded in the office of Judge of Probate of Shelby County: a strip land, beginning at Sta. 1/12, thence 162.1 feet N 22 deg. 54' E, to sta. 2/74.1, thence N 47 deg. 30' E 63 feet to sta. 3/37. Siad strip being 30 feet wide on the right side of the center line and containing 0.11 acres, more or less, said strip of land being in the SE4 of SW4, Sec. 21, Tp. 22 S, Range 3 West.

To Have and To Hold by Shelby County, or its Assigns, and for and in consideration of the benefit to our property by reason of the construction or improvement of said road, we hereby release the County aforesaid, and all of its employees and officers, and the State of Alabema and all of its employees and officers from all consequential demages, present or prospective, to our property, arising out of the construction, improvement, meintenance or repair of said road, and that said road is a benefit to our property is hereby admitted and acknowledged. All agreements covering the moving, relocating and/or changing of the buildings and/or structures located wholly or partially on the above described right-of-way shall be in writing and approved by the State Highway Department before same shall be valid and binding on the said State Highway Department. The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
