 GENERAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS That I, Margaret Kilgore Youngblood, legal resident of the Town or City of Selma, State of Alabama, United States of America, and being desirous of appointing an attorney-in-fact to act for me and on my behalf on all matters in which I may have an interest, have made constituted and appointed, and by these presents do make, constitute and appoint Hugh E. ratifying and confirming whatsoever my said attorney shall and may do by virtue hereof, in the premises.

FURTHER, This power of attorney shall remain in full force and effect until revoked by me.
