Personally appeared before me, Lallage Powell, a Notary Public in and for said County in said State, Pauline Bird, who being by me first duly sworn upon oath deposes and says as follows:

That she is a Register of the Circuit Court of Shelby County, Alabama, and has resided in said County for more than forty (40) years, and that she is familiar with the following described property:

Beginning at the Northeast corner of Section 1, Township 22, Range 1 West and run South 86 degrees and 15 minutes west along the north line of said section 2028.7 feet; thence south 2 degrees and 45 minutes east 517.7 feet; thence North 85 degrees and 25 minutes East 2015.2 feet to the East line of said Section; thence North no degrees and 45 minutes west along said section line 491.6 feet to point of beginning. Being a part of the North Half of Northeast Quarter of Section 1, Township 22, Range 1 West, and containing 23.4 acres more or less.

Also beginning at the Southwest corner of the Southwest quarter of Southeast quarter of Section 36, Township 21, Range 1 West; thence run South 86 degrees and 15 minutes, East 660 feet, thence north 2 degrees and 45 minutes, West 270 feet to point of beginning, thence continue north 2 degrees and 45 minutes west 1050 feet to the north line of said 40 acres; thence south 86 degrees and 15 minutes west 210 feet; thence south 2 degrees and 45 minutes East 1050 feet; thence North 86 degrees and 15 minutes east 210 feet to point of beginning, and being a part of the Southwest quarter of Southeast quarter of Section 36, Township 21, Range 1 West, and containing 5 acres, more or less, situated in Shelby County, Alabama.
