Begin at NE corner of Thomas land on south side of Peavine Creek and run South to Owner's land, then ce half mile along Section line to North and South line, thence a North to middle of Peavine Creek, thence along Creek to eginning, less that part East of A. B. & C. R. R.; Also the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$; also the S $\frac{1}{2}$ of the NE $\frac{1}{4}$; also the SE $\frac{1}{4}$; all in Section 24, Township 20, South Range 3 West.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns forever.
