

WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That in consideration of TWO HUNDRED & NO/100 Dollars to the undersigned grantors Paul H. Gore and wife, Dathine Gore, in hand paid by Charles T. Wadsworth the receipt whereof is acknowledged we the said Paul H. Gore and wife, Dathine Gore, do grant, bargain, sell and convey unto the said Charles T. Wadsworth, the following described real estate, to-wit:

A tract of land situated in Section 30, Township 20, Range 1 East, described as follows: Beginning at a point 340 feet South of the Northeast corner of the Northeast Quarter of the Southwest Quarter of said Section, at a point on the old Page road (now abandoned), and run thence Northeast along said road a distance of 700 feet; run thence a little North of West crossing the East line of the Southeast Quarter of the Northwest Quarter of said Section 30 at a point 325 feet North of the Southeast corner of said forty acres a distance of 320 feet; thence continue said line in the same direction

for a distance of 580 feet to the settlement road known as the Stinson ~~or the road leading from the old Page road to the house formerly known as the W. E. Bentley home;~~ Road, ~~run thence South along said Stinson Road,~~ as aforesaid, a distance of 380 feet to the North line of said
