I, Nannie Denty, a widow for and in consideration of the sum of One & No/100 Dollars (\$1.00) to us in hand paid bu Alabama Power Company, a corporation, the receipt whereof is acknowledged, do her by gr ant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers upon, over and across the following described lands situated in Shelby County, Alabama:

The twenty acres more or less in East half of the NW⁴ of SW⁴ Sec. 21, Tp. 19 R 2 E

The twelve acres more or less in southeast corner The SW⁴ of NW⁴ Sec. 21, Tp. 19 R 2.

The three and one half acres more or less in SW corner of the SE⁴ of NW⁴ Sec. 21, Tp. 19,

R 2 The NE⁴ of SW⁴ Sec. 21, Tp. 19, R 2.

In the event it becomes necessary or desirable for Alabama Power Company to move its lines of poles, towers and appliances in connection with the construction or improvement of any public road or highway in proximity to its said power lines, the said Company is hereby granted the right to relocate its said lines of poles, towers and appliances on lands of grantors hereinabove described, provided, however, the said Company shall relocate its said line of poles or towers at a distance not greater than ten feet outside the boundary of the right of any such public road or highway as established or re-established from time to time.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said 'ompany, its successors and assigns forever.
