Alabama Power 'ompany, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power 'ompany, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith; as located by the final location survey heretofore made by said 'ompany, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers upon, over and across the following described lands situated in Shelby 'ounty, Alabama:

The eight acres more or less in western part of The SW of SE Sec. 28, Tp. 18, R 2 E.

The thirty seven and one half acres more or less in The NE4 of SW4 Sec. 28, Tp. 18, R 2.

In the event it becomes necessary or desirable for "labama Power "ompany to move its lines of poles, towers and appliances in connection with the construction or improvement of any public road or highway in proximity to its said power lines, the said "ompany is hereby granted the right to relocate its aid lines of poles, towers and appliances on lands of grantors hereinabove described, provided, however, the said "ompany shall relocate its said line of poles or towers at a distance not greater than ten feet outside the boundary of the right of way of any such public road or highway as established or re-established from time to time.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said ompany, its successors and assigns forever.
