Champion, and his wife, Ever I. Champion, the receipt whereof is acknowledged I the said Hixie Moore, a widow do grant, bargain, sell and convey unto the said Fred H. Champion, and his wife, Ever I, Chamption, for and fluring their joint lives with remainder upon the death of either of them, to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

Start at the Southeast corner of the Southwest  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  of Section 22, Township 19, Range 1 East, run West along the Southern boundary line of said  $\frac{1}{4}$  Section 208 feet for the point of beginning; thence run North along the Hixie Moore, property line 144 feet; thence run West 104 feet; thence run South 144 feet to the Southern boundary line of said  $\frac{1}{4}$  Section; thence run East along the Southern boundary line of said  $\frac{1}{4}$  Section 104 feet to the point of beginning.

Champion, and his wife, Ever I. Champion, their heirs, and assigns forever against the lawful claims of all persons.
