KNOW ALL MEN BY THESE PRESENTS: That, WHEREAS, on the 13th day of May, 1939, RECONSTRUCTION FINANCE CORPORATION, a corporation organized and existing by virtue of an Act of Congress, executed a power of attorney to EDGAR W. LONG: the powers given to the said FRED H. FOY, of the City of Birmingham, Jefferson County, Alabama, to remain in full force and effect. This revocation shall be effective on and after the 18th day of September, 1946.
