That the party of the first part in consideration of 1.00 paid by the party of the second part, the receipt whereof is hereby acknowledged, do hereby grant, bargain, sell, and conveyunto the party of the second part, its successors and assigns forever, the right to construct, maintain, operate and remove pipes of any kind or description across the following described strip of land:

Beginning at the east right of way line of the Louisville & Nashville Railroad Company and at the northwest corner the warehouse lot, and running thence in an easterly direction along the north line of said warehouse lot, a distance of 232 feet to a point; thence north 202 feet to a point, being the northeast corner of the Harry Gordon lot; thence south 84 degrees 10 minutes west a distance of 57° to point of beginning; thence south 19 degrees west, a distance of 113° then south 84 degrees and 10 minutes west, a distance of 3°; thence north 19 degrees east, a 113°; thence north 84 degrees 10 minutes east, a distance of

distance of/3' to point of beginning; being situated in Columbiana, Shelby County, Alabama, to be used by the party of the second part, its successors and assigns for the purposes named, and for such purposes only, as are incidental to the construction, maintenance, operation and removal of said pipe. It is understood and agreed that any pipes layed across said land will be put twelve inches or more under the ground, and all ditching and refilling will be done in a workman like manner.
