I, Sam M. Adler, of Birmingham, Alabama, being of sound mind and disposing memory, make this my last will, hereby revoking all former wills and codicils by me heretofore made.

Item I. I give, devise and bequeath to my wife, Bertha M. Adler, all my property of every kind and wherever situated, absolutely.

Item II. I appoint as executør of this my will Bertha M. Adler and Maurice R. Scharff and exempt them from giving bond as such and from filing any inventory or accounts in any court.

Item III. I confer on my executors full power to sell, transfer, assign or convey all or any part of my estate for any purpose which to them may seem proper.
