Ray, respectively, who, being first duly sworn depose and say that they are brothers, and are of the ages of 71 years and 76 years, respectively, and that they have resided in Shelby County, Alabama, all of their lives; that they are sons of William H. Ray, deceased; that Erah C. Bolton was a daughter of W. H. Ray, and a half sister of your affiants, and that Allen A. Ray, now deceased, was a son of William H. Ray, and a brother of your affiants; that for a period of more than sixty years, last past, that they have been a equainted with the location boundaries, use, claim of ownership, possession, and ownership of the following lands situated in Shelby County, Alabama, to-wit: All that part of the East Half of the Northeast Quarter of Section 13, Township 20, Range 1 West, that lies South of the road that leads, or runs from the lower bridge to the old house place, and East of the road, the County Public Road, that runs from the old house place to the upper bridge, and all situated in Shelby County, Alabama.

Affiants further say that on November 26, 1898, the widow and all of the heirs at law of William H. Ray, deceased, conveyed to Sarah C. Bolton all of the above described lands situated North and West of Yellow Leaf Creek; and that said Sarah C. Bolton paid at that time the purchase money to the above named grantors, and That the said Sarah C. Bolton was put into the possession, by the above named grantors, of all of the lands situated North and West of said Yellow Leaf Creek, and South of said road that runs from lower bridge to the old house place; affiants further say that of their own personal knowledge they know that for more than sixty years, last past, the above described lands have been cleared and regularly, each year, been in cultivation of agricultural crops by the said Sarah C. Bolton and the several succeeding owners to the present date.

Affiants further say that of their own personal knowledge they know that for the past sixty years that Nora Arthur, and those through whom she holds title, namely, Ollie Johnson, J. H. Billings and wife, Eula Billings, Della Mae Johnson Bickle, E. V. Johnson, Mollie Johnson, Allen A. Rey, S. S. Childers, Mrs. J. E. Edmondson, Henry Milner, the heirs at law of J. W. Edmondson, deceased, J. A. Edmondson, J. F. McDonald, J. E. Ray and Sarah C.
