We, Frank Doss and wife Bell Doss for and in consideration of the sum of One and No/100 Dollars (\$1,00) to us in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grafit to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location shrvey heretofore made by said Company, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers upon, over and across the following described lands situated in Shelby County, Alabama:

Beginning at the SW corner of the SW of NW Sec. 18, Tp. 20 R 3 W. thence running North 2 the distance between the SW corner and the NW corner of said Forty, thence run due East to a point which is ½ the distance between the West boundary and the East boundary of said forty, thence West to the point of beginning containing ten acres of land is designated as tract more or less, said tract/#3 situated lying and being in the County of Shelby and state Alabama.

In the event it becomes necessary or desirable for Alabama Power Company to move its lines of poles, tower's and appliances in connection with the construction or improvement of any public road or highway in proximity to its said power lines, the said Company is hereby granted the right to relocate its said lines of poles, towers and appliances on lands of grantors hereinabove described, provided, however, the said Company shall relocate its said line of poles, or towers at a distance not greater than ten feet outside the boundary of the right of way of any such public road or highway as established or re-established from time to time.

Together with all the rights and privileges necessary of convenient for the full enjoyment of use thereoff, including the right of ingress and egress to and from said lines; adn alsothe right to cut andkeep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns forever.
