The SEL of the SEL Section 26, Township 19, Range 3 West

The NWL of the NEL, Section 25, Township 19, Range 3 West.

In the event it becomes necessary or desirable for Alabama Power Company to move its lines of poles, towers and appliances in connection with the construction or improvement of any public road or highway in proximity to its said power lines, the said Company is hereby granted the right to relocate its said lines of poles, towers and appliances on lands of grantors hereinabove described, provided, however, the said Company shall relocate its said line of poles or towers at a distance not greater than ten feet outside the voundary of the right of way of any such public road or highway as established or re-established, from time to time.

Together with all the rights and privileges necessary of convenient for the full enjoyment of use thereof, including the right of ingress andegress to and from said lines; andalso the right to cut and keep clear all trees, and to keep clear other obstruction, that may injure or endanger said lines.

TO HAVE AND TO HOLD the smae to the said Company, its successors and assigns, forever.
