We. Joe Newsome adn wife Cornelia Newsome for and in consdieration of the sum of One and No/100 Dollars (\$1.00) to us in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by the said Company, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other carporations and persons to attach wires to said poles and towers upon ; over and across the following desceibed lands situated in Shelby County, Alabama:

Part of NW $\frac{1}{4}$  - begin at SE corner of Fowler land on Montgoemry Road and rum West to Section line; South 22 yards; East to Montgomery Road; North along Road 200 yds. to beginning, less lot on North Side of Columbiana Road, also lot in NE $\frac{1}{4}$  of NE $\frac{1}{4}$ , begin at SE corner of Dry Branch Church lot and run SW along road 40 yds. East 128 Yds North 281 yds; East 58 yds; to church lot; West to beginning; also part of N $\frac{1}{2}$  of N $\frac{1}{2}$  of NW $\frac{1}{4}$  South of Columbiana Road, west of Montgomery Road and that part East of old Montgomery Road- All in Section 12 Township 21 South Range 1 East.

In the event it becomes necessary or desirable for Alabama Power Company to move its lines of poles, towers and appliances in connection with the construction or improvement of any public raod or highway in proximity to its said power lines, the said Company is hereby granted the right to relocate its said lines of poles and towers and appliances on lands of grantors hereinabove described, provided, however, the said Company shall relocate its said line of poles or towers at a distance not greater than ten feet outside the boundary of the right of way of any such public road or highway as established or re-established from time to time.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obatructions, that may injure or endanger said lines.

TO HAVE TO HOLD the same to thw said Company, its successors and assigns forever.
