We, A. F. Blackerby and wife Katie Blackerby for Wand in consideration of the sum of One and No/166 Dollars (\$1.00) to us in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and tewers upon, over and across the following described lands situated in Shelby County, Alabama:

Commence at point about 100 yds S of NE cor of said NW of Et the W 50 yds South 150 yds to Calera Public Road the E 50 yds to E B'dry line of said 40A the North along East line to Beg. Sec 34 Tp 19 R lW.

In the event it becomes necessary or desirable for Alabama Power Company to move its lines of poles, towers and appliances in connection with the construction or improvement of any public road or highway in proximity to its said power lines, the said Company is hereby granted the right to relocate its said lines of poles and appliances on lands of grantors hereinabove described, provided, however, the said Company shall relocate its said line of poles or appliances at a distance not greater than ten feet outside the boundary of the right of any such p public road or highway as established or re-established from time to time.

TO HAVE AND HOLD the same to the said Company, its successors and assigne forever.
