KNOW ALL MEN BY THESE PRESENTS, THAT IN CONSIDERATION OF ONE & No/100 and other valuable consideration Dollars to the undersigned grantors Guy Turner and wife, Eunice Turner in handpaid by William Taylor and wife Evelyn Taylor, the receipt whereof is acknowledged, we the said Guy Turner and wife, Eunice Turner do grant, bargain, sell, and convey unto the said William Taylor and wife, Evelyn Taylor and wife, Evelyn Taylor the following described real estate situated, lying, and being in the Tounty of helby, State of Alabama, to wit:

The North Half of the Northeast Quarter of Section 22, Township 18, Range 2 East, containing 80 acres more or less.

Also, 15 acres on the "est side of the Northeast Quarter of the Northwest Quarter, and all of the Northwest Quarter of the Northwest Quarter, except 10 acres in the Southeast corner thereof, all in Section 23, Township 18, Range 2 East, containing 45 acres more or less.

Also, the North Half and one-half of a rod of the Southeast quarter of the Southeast Quarter of Section 15, Township 18, Range 2 Last; and also, a part of the North half of the Forthwest Quarter of Section 23, Township 18, Range 2 Last, lying as follows: Beginning at a certain made line between the lands formerely known as the L.W. Turner lands, and the lands formerly known as the A.G.
