Before me, W.J. Horsley, a Notary Public in and for said county in said State, personally appeared Lewis M. Davis, who being by me duly sworn deposes and says as follows:

I am now 67 years of age and have been living in this county all of my life. I am familiar with the location of the folloiwng described lands to-wit:

The $W\frac{1}{2}$ of $E\frac{1}{2}$ of $SW\frac{1}{4}$ of Section 6 and 3 acres in the NW corner of the $NE\frac{1}{4}$ of $NW\frac{1}{4}$ of Section 7 all in Township 20 Range 1 West, in Shelby County Alabama, and have known this land all my life. My father, E.M. Davis once owned this land and I was raised on the land with my parents and the family for many years. My father owned the land when he died and he died about 10 or 12 years ago, and left surviving him at the time of his death the following heirs, viz: Affiant, Lewis M. Davis, whose wife is name Minnie Davis, R.E. Davis, ~~R.E. Davis~~ whose wife is named Lula Davis, Zillie Davis who married R.H. Howard; John A. Davis whose wife is Era Davis; and Esker Davis whose wife is named Edna Davis, These were all he children the said E.M. Davis ever had. My mother dies before the death of my father. My father the said E.M. Davis, never left any will at his death, and that there was no a dministrator ever appointed of the estate of said E.M. Davis and that the debts against thee state of my said father has been paid.

Affiant further states that he knew A.W. Kendrick and Norman Shirley, and affiant knows of my own knowledge that neither A.W. Kendrick nor Norman Shirley ever claimed any part of this land nor any interest therein and that neither of these parties were ever in possession of the same or any part thereof. Affiant further says that he knows of his own knowledge that no one by the name of Eva Waggoner or J.R. Wagoner ever owned said land or any part thereof or were ever in possession of the same; further that J.T. Leeper never claimed any part of said land now were ever in possession of the same, so far as affiant ever know or heard of.

The said land now belongs to A.L. Blackerby and wife and the said A.L. Blackerby and his predessors in title have been in possession of the said land continuously since my father purchased the same many years ago and that their possession were adverse, continuous, open, and peaceable during all these years.
