

ASSIGNMENT OF MORTGAGE

Paul, the receipt of which is hereby acknowledged, undersigned does hereby transfer, set-over and assign to William F. Schaeffer, as Trustee of Superior Lime & Hydrate Company, Inc., a corporation, in bankruptcy, that certain mortgage from Superior Lime & Hydrate Company, Inc., to undersigned dated heretofore, to-wit:

20th day of May, 1927, and recorded in the office of the Probate Judge of Shelby County, Alabama, in record of Mortgages, Vol. 149, page 283, together with extension agreement with reference to said mortgage, which said extension agreement is dated, to-wit, the 1st day of May, 1937, and signed by Superior Lime & Hydrate Company, Inc., and recorded in the Office of the Probate Judge of Shelby County, Alabama, in Record of Mortgages, Vol. 176 at page 173; and

Undersigned likewise transfers and assigns to said William F. Schaeffer, as such Trustee, all his right, title, claim and interest in and to three promissory notes executed on, to-wit the 1st day of May, 1937, in the principal sum of \$3250.00 each, referred to in said extension agreement above described, and likewise the promissory notes numbered 12, 13, 14, 15, 16 and 19 dated April 1, 1927, being in the principal sum of \$1500.00 each, executed to the undersigned by Superior Lime & Hydrate Company, referred to in said original mortgage above described, dated May 1, 1927; and

Undersigned does hereby release, quit claim and convey unto the said William F. Schaeffer, as Trustee of Superior Lime & Hydrate Company, Inc., in bankruptcy, all his right, title and interest in or claim to the property described in said mortgage dated May 20, 1927, said last named mortgage being recorded in Vol. 149, page 283, Record of Mortgages, in the Probate Judge's Office of Shelby County, Alabama.

It is further understood and agreed that said above described notes are transferred without recourse on undersigned and said mortgage and extension agreement are transferred without warranty or undertaking of any character on the part of undersigned.
