

MINUTES OF SPECIAL MEETING OF THE MAYOR
AND TOWN COUNCIL OF THE TOWN OF WILSONVILLE,
ALABAMA, HELD ON JULY 23, 1948.

A call meeting of the Town Council of the Town of Wilsonville, Alabama, was held at the following location, Mayor's office, in the Town of Wilsonville, Alabama, the regular place for holding meetings of said Council on the 23rd day of July, 1948, at 6 o'clock P.M. and there were present at said meeting, E.R. Lindsey, Mayor and the following Councilmen:

Josh Roper, Dewey Bolton, Arthur Mooney, and R.R. Roberson;
the same constituting a quorum.

The said meeting having been specially called for the purpose of adopting a Resolution giving the assent of the Mayor and Town Council for the following sub-division in the Town of Wilsonville, Alabama to be vacated, namely:

B.J. Owens addition to Wilsonville, Shelby County, Alabama, being a part of S $\frac{1}{2}$ of NW $\frac{1}{4}$ of Section 6, Township 21, Range 2 East, which map was certified by T.O. Sparks, County Surveyor, Columbiana, Alabama, on October 6, 1924, as shown by map recorded in the Probate Office of Shelby County, Alabama;

And each of the members of the Council named below having waived notice of said meeting which said waiver is in words and figures as follows:

Sparks, County Surveyor, Columbiana, Alabama, on October 6, 1924, as shown by map recorded in the Probate Office of Shelby County, Alabama:

and do consent that said meeting for said purpose be held at the following location, Mayor Office, in the Town of Wilsonville, Alabama, at 6 o'clock P.M. on the 23rd day of July, 1948.

The Mayor having declared the meeting open for business, there was a general discussion of an application by Raymond A. Robinson to vacate B.J. Owens addition to Wilsonville, Shelby County, Ala. Whereas it appears that said addition is located within the limits of the Town of Wilsonville, Alabama: and whereas, it appears that none of the streets or alleys in said addition are open or in use by the public. Whereupon Councilman Arthur Mooney introduced the following Resolution:

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF WILSONVILLE, ALABAMA, AS FOLLOWS:

That the assent of the Mayor and Town Council of said Town be and the same is hereby given for the following addition to be vacated, namely:

B.J. Owens addition to Wilsonville, Shelby County, Alabama, being a part of S $\frac{1}{2}$ of NW $\frac{1}{4}$ of Section 6, Township 21, Range 2 East, which map was certified by T.O. Sparks, County Surveyor, Columbiana, Alabama, on October 6, 1924, as shown by map recorded in the Probate Office of Shelby County, Alabama.

Said Resolution was read at length, and thereupon Councilman Arthur Mooney moved that unanimous consent of the Mayor and Council be given for the immediate consideration of, and action upon said Resolution, which motion was seconded by Councilman Dewey Bolton, Said motion for unanimous consent was submitted to a vote of the Mayor and Council and said vote resulted as follows:

Thereupon, the Mayor in Open Council declared said motion carried and unanimous consent given for the immediate consideration of, and action upon, said Resolution.

Councilman Josh Roper moved that said Resolution be adopted, which motion was seconded by Councilman Dewey Bolton; said motion for the adoption of said Resolution was submitted to a vote of the Mayor and Council and said vote resulted as follows:
