That WILTON LAND AND IMPROVEMENT COMPANY, a corporation (hereinafter called party of the first part), for and in consideration of the sum of three thousand six hundred eighty and 00/100 dollars (two thousand dollars of which is in hand paid, the receipt whereof is hereby acknowledged, balance to be paid, as evidenced by notes given therefor) by F. M. SCHOFIELD, W. B. SCHOFIELD and R. C. SCHOFIELD (who are hereinafter called parties of the second part) have granted, bargained and sold, and does, hereby, grant, bargain, sell and convey unto said parties of the second part, the following described real estate, situated in said Shelby County, and Bibb Counties, Alabama, to-wit:

The east half  $(E_2^{\frac{1}{2}})$  of the southwest quarter  $(S. W. \frac{1}{4})$  of the southwest quarter  $(S. W. \frac{1}{4})$  of Section seventeen (17), and the southeast quarter  $(SE_n^{\frac{1}{4}})$  of the southeast quarter  $(S. E. \frac{1}{4})$  of section eighteen (18), and all that part of the northeast quarter  $(N. E. \frac{1}{4})$  of section nineteen (19) which lies east of the right of way of the Southern Railway, except the following described parcel: Beginning at the point of intersection of the east line of said right of way with the south line of said N.
