For and in consideration of the sum of ONE (\$1.00) DOLLAR, cash, in hand paid by party of the second part to party of the first part, the receipt of which is hereby acknowledged, the party of the first part has remised, released and quit claimed, and does by this Indenture remise, release, quit claim and convey unto the party of the second part the following described land situated in Shelby County, Alabama, namely:

That part of northeast quarter of northeast quarter of Section 24, Township 22, Range 3 West described as follows:

Begin at a point  $\frac{1}{4}$  chains north of the southeast corner of said northeast quarter of northeast quarter, and thence run west 20 chains, thence north  $\frac{1}{4}$  chains, thence east 20 chains, thence south  $\frac{1}{4}$  chains to the point of beginning.

TO HAVE AND TO HOLD the aforesaid property, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining unto the party of the second part, and unto her heirs and assigns, in fee simple.
