Lots 1 to 5 inclusive of cedar Grove Estates as recorded in Plot Book 3 Page 53, in office of Judge of 5 acre home place lying East of U.S. Hwy, # 31, and bounded on the north by above recorded Probate, survey in the North west Quarter of the North West Quarter, Section 36 Township 20 South, Range 3 West.

In the event it becomes necessary or desirable for Alabama Power Company to move its linesof poles, towers and appliances in connection with the construction or improvement of any public road or highway in proximity to its said power lines, the said Company is hereby granted the right to relocate its said lines of poles, towers and appliances on lands of grantors hereinabove described, provided, however, the said Company shall relocate it s said line of poles or towers at a distance not greater than ten feet outside the boundary of the right of way of any such public road or highway as established or re-establihsed from time to time.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use there# of, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that mayyinjure or endanger said lines.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns forever.
