Looney and wife Alma Looney in hand paid by Howard Hall the receipt whereof is hereby acknowledged we do remise, release, quit claim and convey to the said Howard Hall all our right, title, interest and claim in or to the following described real estate, to-wit:

Begin at the southwest corner of SE $\frac{1}{4}$  of SW $\frac{1}{4}$  of Section 7, Township 22, Range 1 West and run north 85 degrees 15 minutes east along the south line of said forty acres and along the south line of SW $\frac{1}{4}$  of SE $\frac{1}{4}$  and along the south line of W $\frac{1}{2}$  of SE $\frac{1}{4}$  of SE $\frac{1}{4}$  all in said Section 7, a distance of 3443 feet; thence north 2 degrees 30 minutes west, 795.5 feet; thence south, 85 degrees 30 minutes west, 3443 feet to the west line of SE $\frac{1}{4}$  of SW $\frac{1}{4}$  of said Section 7; thence along the west line of said forty acres south, 2 degrees 30 minutes east, 795.5 feet to the point of beginning; being situated in Shelby County, Alabama.
