I am acquainted with James L. Lee, who on January 7, 1889, purchased that property described in that certain deed recorded in Deed Book 14 at page 542, in the Probate Office of Shelb-y County, Alabama, from Needham Lee and wife, Matha Lee, This particular James L. Lee is one and the same person as J.L. Lee, who, on April 11, 1912, deeded a portion of the first above mentioned property to Sam and S. L. Burk. Said deed being recorded in Deed Book 49 at page 359, in the Probate Office of Shelby County, Alabama.

In connection with the same property and in reference to a subsequent owner I further certify that the grantee, John W. Stone, who obtained title by deed dated April 2, 1929, recorded in Deed Book 88 at page high is one and the same person as Jno. W. Stone, whose name appears as grantor in a deed conveying a portion of said property to Luther H. Nunnally, by deed dated December 10, 1931, and recorded in Deed Book 117 at page 167, in the Probate Office of Shelby County, Alabama.

My parents were Thomas B. and Annie P. Miller. I know that they conveyed certain property to Nannie E. Hays in 1895, reserving for themselves a life estate. I certify that Thomas B. Miller and Annie P. Miller are now deceased, and that they died approximately 1905, and 1921 respectively.

Nannie E. Hayes was my sister. My parents, as above mentioned, did convey certain lands to her on the 20th day of March, 1895, The deed of conveyance is recorded in Deed Book 21 at page 199, in the Probate Office of Shelby County, Alabama. My sister, Nannie, therein named is Nannie E. "Hayes," and her correct name is "Hays." She died about 1916 and in 1944 her heirs conveyed portions of the property that she received from Thomas B. And Annie P. Mil ler in the deed above mentioned which is dated March 20, 1895, to H.H. Knowles. This last mentioned deed is dated 10, July, 1944, and is recorded in Deed Book 119 at page 37 in the Probate Office of Shelby County, Alabama. The grantors named therein are as follows: Walter M. Hays and wife, Nannie Moore Hays: Edith Hays Walker and husband W.A. Walker: Carlotta W. Hays, a widow: Roberts B. Hays, Jr., and wife, Katherine Hays: Elizabeth Hays Starnes and husband, Burlin R. Starnes, Jr.,; John H. Hays and wife, Nellie B. Hays: Lucile Hays McKenzie, a widow; Dorothy Hays Turner and husband, George F. Turner. I certify that the above named grantors constituted all of the heirs at law of Nannie E. Hays on the date borne by said deed.
