KNOW ALL MEN BY THESE PRESENTS, That we, S.E. McGraw and R.T. McGraw, as Executors of the Last Will and Testament of J.F. McGraw, Sr., do hereby constitute and appoint Paul O. Luck of Columbiana, Alabama, our true and lawful attorney for us and in our name and behalf as such Executors to mark paid and satisfied of record on the margin of the record of that certain mortgage executed on January 26, 1931, by J.F. McGraw, Jr., and wife, Virginia McGraw to Dent F. Green, as Superintendent of Banks of the State of Alabama, securing the sum of \$787.09, which said mortgage is recorded in Mortgage Book Volume 155, on page 331, in the office of the Judge of Probate of Shelby County, Alabama, and which said mortgage was heretofore on to-wit, the 17th day of March, 1934, transferred, assigned, and sold to J.F. McGraw, Sr., by H.H. Montgomery, as Superintendent of Banks of the State of Alabama; also, to mark paid and satisfied of record on the margin of the record of that certain mortgage executed on February 6, 1928, by J.F.
