WHEREAS, after the death of Bessie R. Brown in the year 1933, her heirs at law and legal representatives appointed me as the agent of the Estate of Bessie R. Brown, Deceased, to receive and receipt for all monies due to said Bessie R. Brown and further authorized me to satisfy any mortgages of record in connection with the collection of said money.

Whereas I, as such agent did, subsequent to the death of the said Bessie R. Brown and subsequent to the date of my appointment as such agent, collect from P.C. Wilson the balance due on that certain mortgage from P.C. Wilson to Bessie R. Brown dated February 21, 1931, and recorded in Mortgage Book 155 page 340 in the Probate Office of Shelby County, Alabama, which mortgage covered the following property:

A part of lot No. 21 according to the original plan of the Town of Montevallo as recorded in the office of the Probate Judge of Shelby County, the said part hereby conveyed being described as follows: Beginning at the northernmost corner of said Lot 21, said point being the southermost paint of intersection of Middle and Valley Street, according to the original plan, thence running southwest along the southeast margin of Valley Street a distance of 75 feet to its intersection of the line between lots 20, and 21, thence southeast and parallel with Middle Street a distance of 50 feet, thence northeast and parallel with Valley Street a distance of 75 feet to the westermost margin of Middle Street, thence northwesterly along said margin of Middle Street to the point of beginning and being in said Town of Montevallo, Shelby County, Alabama.

WHEREAS, through some oversight said mortgage was not satisfied of record.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, That I, F. W. Rogan, as the Agent of the Estate of Bessie R. Brown, deceased, do hereby constitute and appoint L.C. Walker, of Columbiana, Alabama, my attorney with full power of substitution for me and in my name to satisfy off the records in the Probate Office of Shelby County Alabama said mortgage from P.C. Wilson to Bessie R. Brown, dated February 21, 1931, and recorded in Mortgage Book 155 page 340, by writing the following words on said mortgage record in said Probate Office; "This mortgage having heretofore been paid in full, it is hereby satisfied of record. Dated this 10th day of November, 1949.
