KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Fifteen Hundred and no/100 Dollars, to Frank Fulton in hand paid by Lorraine Cox Fulton the receipt whereof is hereby acknowledged I do remise, release, quit claim and convey to the said Lorraine Cox Fulton all my right title interest and claim in or to the following described real estate, to wit:

A Part of the NW $\frac{1}{4}$  of NE $\frac{1}{4}$  of Section 34, Township 21, Range 1 West, described as follows: Begin at the southwest corner of said forty acres and run thence east along the south line of said forty acres 300 feet, more or less, to the northwest side of the right of way line of the paved highway leading from Columbiana to Calera; thence northeast along the northwest side of said right of way 150 feet, more or less, to the southwest corner of the J.M. Crawford lot; thence northwest along said Crawford lot 210 feet to the northwest corner of said Crawford lot; thence east and parallel with said highway 210 feet to the Frank Fulton Road; thence northwest along said road 840 feet, more or less, to the west line of said forty, thence south along said line 893 feet, more or less to the point of beginning; containing 12 acres, more or less.

Also the NE $\frac{1}{2}$  of NW $\frac{1}{4}$  of Section 34, Township 21, Range 1 West, except a lot or parcel of land being described as follows: Begin at the northeast corner of said forty acres and run in a southwesterly direction approximately 685 feet to an iron stake which is the beginning point and the northeast corner of the property herein excepted; from said beginning, run thence south 340 feet to a stake; thence west 200 feet; thence north 340 feet; thence east 200 feet to the point of beginning.

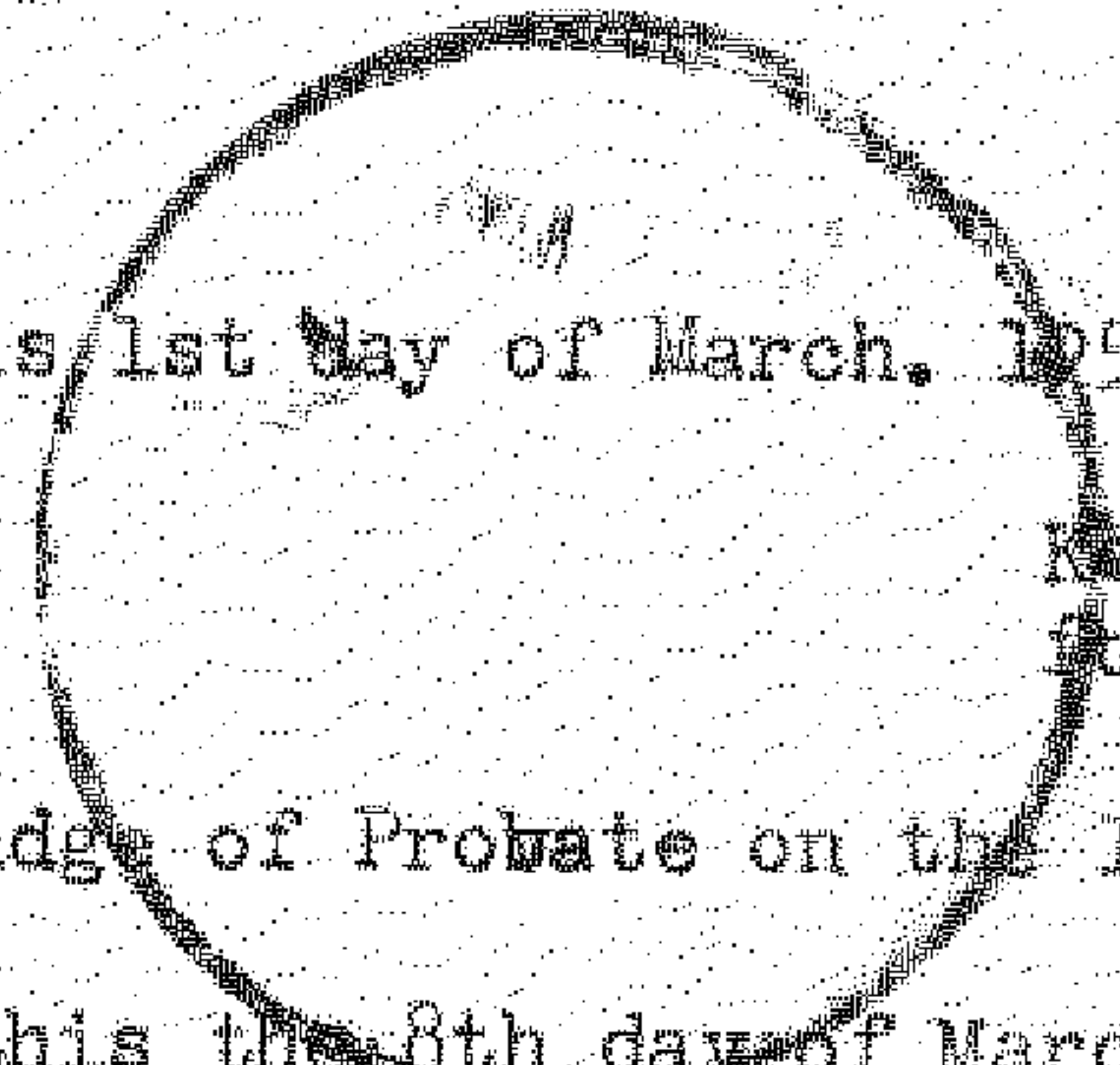
