KNOW ALL MEN BY THESE PRESENTS, That Whereas W.E. Waddell, a widower hereinafter called Grantor, did on March 1, 1948, execute and deliver to F.M. Strother, hereinafter called Grantee, a deed which is recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Deed Book 132 at page 414, by which he intended to convey the land hereinafter described, but did through error except a small portion which was not intended to be excepted, and Whereas, Grantor is desirous of correcting said deed and of conveying to Grantee all the land intended to be conveyed by said deed of March 1, 1948. NOW THEREFORE, for and in consideration of the premises and the further consideration of One and no/100 Dollar to Grantor in hand paid by Grantee, the said W.E. Waddell does grant, bargain, sell and convey unto the said F.M. Strother, his heirs and assigns, the following described real estate, situated in Shelby County, Alabama, to-wit:

South half of Northeast Quarter of Southeast Quarter and all of the South half of the Southeast Quarter East of the creek forming a track of 70 acres, more or less in Section 21, Township 19, Range 1 East. Except 1 acre described as follows: Begin at Southeast corner of Southeast Quarter of Southeast Quarter of Section 21, Run West 268 feet for a beginning point and run North 70 yards ; thence West 70 yards, thence South 70 yards, thence East 70 yards to point of beginning, 1 acre more or less, situated in Shelby County, Alabama.

TO HAVE AND TO HOLD, to the said F.M. Strother, his heirs and assigns forever.
