KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of One Hundred Dollars (\$100.00) and other valuable considerations to the undersigned grantor O.C. Harris, and wife, Clara Harris in hand paid by Southern Natural Gas Company, a Delaware Corporation, the receipt whereof is acknowledged we the said O.C. Harris and wife, Clara Harris do grant, bargain, sell and convey unto the said Southern Natural Gas Company the following described real estate in Shelby County, Alabama, viz:

Commence at the Northwest corner of NE $\frac{1}{4}$  of Section 5, Township 24 North, Range 13 East; thence Southernly and along the Westerly line thereof 1,529.78 feet to the Northerly right of way line of State Highway No. 25; thence turning an angle of 95 degrees 40 minutes 30 seconds to the left in an Easterly direction and along said right of way line of said State Highway 267.66 feet to the point of a curve turning to the right and having a radius of 1,788.18 feet; thence continue Easterly and along the arc of said last mentioned curve 24.0 feet to point of beginning; thence continue easterly along the arc of said last mentioned curve; and along the above mentioned right of way line of said Highway 100.13 feet to the Westerly right of way line of Plantation Pipe Line Company; thence at an angle to the left of 81 degrees 40 minutes from the chord of said last mentioned arc and along the Westerly right of way line of said Plantation Pipe Line Company in a Northerly direction 156.01 feet; thence turning an angle of 100 degrees 22 minutes to the left and in a Westerly direction 128.02 feet; thence turning an angle to the left of 90 degrees 00 minutes in a Southerly direction 150.0 feet to the Northerly right of way line of said State Highway No. 25, the point of ending, situated in Shelby County, Alabama.

TO HAVE AND TO HOLD, TO THE SAID Southern Natural Gas Company, its successors and Assigns forever.

And we do, for ourselves, our heirs, executors and administrators, covenant with the said Southern Natural Gas Company, its successors and Assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances, and that we have a good right to sell and convey the same as aforesaid; that we will, and our heirs, executors and administrators shall, warrant and defend the same to the said Southern Natural Gas Company, its successors and assigns forever, against the lawful claims of all persons.

There is excepted herefrom taxes for the current tax year 1950 which grantee assumes and agrees to pay.
