JONES the receipt whereof is hereby acknowledged, I or we G.C. Burks and wife, Ettie O. Burks, have this day bargained and sold, and do by these presents grant, bargain, sell and convey to the said John R. Jones and Jessie B. Jones, their heirs and assigns, the following described real estate, situated, lying and being in the County of Shelby State of Alabama, to-wit:
